BACKGROUND

Nick Vitullo, a sole practitioner tax preparer, was struggling with the unreliability and stress of a reactive, local IT provider. 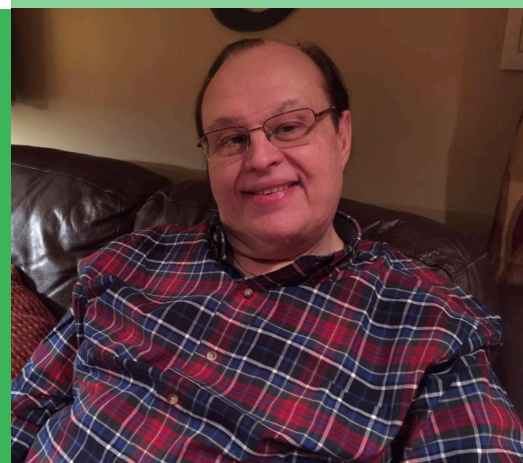
